In place of the words "should not have completed 24 years of age as on 01.12.2019" the words "should not be more than 24 years of age as on 01.12.2019" should be substituted.

The complete sentence should be read as "Candidate must have completed 15 years and should not be more than 24 years of age as on 01.12.2019."

Subject: Engagement of Act Apprentices under Apprentice Act, 1961 for the year 2019-20 in North Central Railway, Wagon Repair Workshop, Jhansi

In terms of Railway Board's instructions in their letter No. E(MPP) 2013/6/14 dated- 03.12.2019, the panel of Act Apprentices is proposed to be formed through online process. Accordingly, applications for 196 seats are invited for Act Apprenticeship Training under Act Apprentice Act, 1961 by North Central Railway, Wagon Repair Workshop, Jhansi.

Eligible candidates may apply and register their application w.e.f. 01.06.2020 to 15.07.2020 on website www.mponline.gov.in.

Details of the seats in different trades are given below:-

- 01. Reservation as per instructions contained in Rly Bd's L.No E(MPP) 2002/6/10 dated- 17.06.11, will be SC 15%, ST 7.5% and OBC 27%. If adequate candidates belonging to Scheduled castes and Scheduled Tribes are not available, then the seats so reserved for them may be filled by candidates belonging to ST by SC and SC by ST as the case may be. If the prescribed seats cannot be filled even in the manner given above, then the seats lying unfilled may be filled by candidates other than SC or ST. Similarly the seats remaining unfilled for OBC candidates will be filled by unreserved category.
- 3% of total seats are reserved for Ex. Servicemen, their children and children of armed Forces, Personnel, as per details mentioned below- (Authority- E(MPP) 2002/06/VI dt. 31.07.2006)
 - a) Children of deceased/disabled Ex-Servicemen including those deceased/disabled during peace time.
 - b) Children of ex-servicemen.
 - c) Children of serving jawans.
 - d) Children of serving officers.
 - e) Ex-servicemen.
- 3% of total seats will be reserved for physically handicapped candidates. Only locomotor disabled or Cerebral palsy (OH) who suffers from 40% or more than 40% of relevant disability and hearing handicapped having 60 decibels or more in ear in the conversational range of frequency are eligible to apply. A physical handicapped person who wants to avail the benefit of reservation will have to submit a disability. Certificate issued by a competent authority i.e. Medical Board constituted by the Central Government.

- Every candidate is required to register on website www.apprenticesip.gov.iii before applying
 After registration, candidate should apply for the seats notified by N.C. Railway. Wagon Repair
 Workshop Jhansi in the enclosed proforma with all relevant documents. Apair from this, a copy of
 registration slip must be sent to this office along with the application otherwise application will not
 be entertained. Procedure for registration and relevant information can be obtained from the r-AQ
 mentioned at right conter of the website www.apprenticeship.gov.in.
- 2. <u>Training Period and Training Place</u>. Training period will be as prescribed vide Railway Board's letter dated 31.05.2017 (RBE- 54/2017). Training place will be N.C. Railway, Wagon Repair Workshop, Jhansi

Eligibility-

- 3. Age limit-
 - Candidate must have completed 15 years and should not have completed 24 years of age as on 01.12.2019.
 - The upper age limit may be relaxed by 5 years in case of SC/ST candidates and 3 years in case of OBC candidates.
 - For physically handicapped persons, upper age limit is relaxed by 10 years.
- 4. <u>Educational qualification</u>- The candidate must have passed 10th class examination or its equivalent (under 10+2 system) with minimum 50% marks and ITI passed certificate in relavant trade from a recognized Industrial Training Institute affiliated to NGVT. Certificate issued by Principal will not be accepted.
- 5. Stipend- Stipend will be paid as per instructions issued by Railway Board from time to time

6. Fee-

An application fee of Rs. 100/- and portal fee of Rs. 70/- + G\$T is to be paid by the candidate. The SC,ST, Physically handicapped and Women candidates are exempted from application fee. However, portal fee of Rs.70/- + GST will compulsonly be paid online by all candidates.

7. Mode of Application- Willing candidates may register and apply online on the website www.mponline.gov.in.

Important Instructions-

Only eligible candidates should apply who fulfill the eligibility conditions mentioned in the notification. They should carefully read the advertisement. If they are satisfied that they fulfill the eligibility and other terms and conditions applicable and have all the requisite documents at the time of applying, then they should register and apply on www.mponline.gov.in. Candidate has to fill all the particulars in one go. After filling all the details, the candidate should see its preview. Edit option is available for correcting the data A registration number will be allotted after submitting the form. A point out of the form filled completely in all respect must be kept by the candidate with him/her.

Essential Documents-

- Personal Email/valid Id.
- Scanned Photo, Signatures, and left thumb impression in JPEG format, the size of which should not exceed 200 kb.
- III) Candidate's name and parents (father and mother) name's spellings should be the same as given in High School Certificate.
- IV) The name of the candidate, address, pin code, mobile number, RDAT Registration Number and registration number, if registered in employment office must be explicitly filled by the candidate.

- VI) Two physical identification marks
- VII) Matriculation Marksheet and certificate issued by respective Board, ITI marksheet and certificate issued by NCVT must be attached duly scanned. Applicantions attached with marksheets and certificates obtained from internet will be summarily rejected.
- VIII) Caste certificate (SC/ST/OBC) and physical disability certificate must be attached duly scanned
- IX) Candidate should attach scanned copy of Aadhaar Card and PAN Card as an identity proof

- 8. Before applying online, applicant should satisfy. himself that he is fulfilling desired qualification, eligibility and other terms and conditions. Administration has the right to cancel the application at any stage of selection. If candidate is not fulfilling the requisite qualification and has been erroneously selected, the candidature of such candidate will be terminated without any information.
- 9. Candidate not possessing the ITI certificate issued by NCVT are not eligible to apply. In such applications, no correspondence will be made with any person or organization .
- 10. Selection Process- Panel will be formed as per the instructions contained in North Central Railway Headquarters office, Prayagraj's letter No. 797-E/Trg/Act.App.1961/NCR/2013 Part-11 d 23.11.15
- (i) The selection of Act Apprentice for training will be done on the basis of ment list prepared from the list of eligible candidates. There will be no written or oral examination for this selection.
- (ii) Merit list will be prepared on the basis of average of percentage of marks obtained in 10th or equivalent examination from any recognized Board/Institute and percentage of marks obtained in ITI
- (iii) The calculation of percentage of marks will be based on the total marks obtained in 10th or its equivalent examination from an education Board/Institute and not on the basis of marks of any subject or a group of subjects.
- (iv) If more than one candidate get equal average marks/percentage, than the older candidate will rank higher in the list. The above information will be computerized and the merit will be prepared in this manner.
- (v) Final select list will be prepared Tradewise, Communitywise, Categorywise, Reservationwise prepared out of the combined merit.
- (vi) The select list equal to twice the number of Act Apprentices slot will be prepared i.e. main list equal to number of Act Apprentices slot and waiting list of equal number of candidates. Candidate equal to the number of Act Apprentices slot will be called from the main list for document verification and medical examination. Thereafter, candidates equal to the number of candidates found unsuitable during document verification or medical examination or being absent will be called from the waiting list in order of merit and seniority.
- (vii) The candidate will be eligible for training only after being declared medically fit by Authorized Railway Medical Officer. If the candidate fails in medical examination, his/her claim for training will not be accepted.
- (viii) No Daily allowance or Travelling allowance will be payable to the candidates called for document verification and medical examination.
- 11. Hostel/Residential facility will not be provided to selected candidates. The selected candidates will have to make boarding and lodging arrangements themselves during the course of training period.
- 12. The merit list of selected candidates will be uploaded on the North Central Railway's website www.ncr.indianrailway.gov.in and candidates included in eligible list will be informed by post. No correspondence will be made in this regard with other candidates
- 13. It is made clear that there is no guarantee of Indian Railways to provide employment after training. (Authority- Railway Board's L.No.E(MPP)2009/6/14 dt. 06.10.15)
- 14. The candidates who have already completed their training under Apprentice Act, 1961 from any other institute/establishment are not eligible to apply under this notification.
- 15. <u>Agreement of Training-</u> The selected candidate or his/her guardian(in case of minor) has to execute an apprenticeship contract or agreement with employer before apprenticeship training as prescribed under the Apprentice Act, 1961.
- 16. After completion of training every apprentice has to undertake Trade Test on all India level conducted by Director General, Employment & Training, Ministry of Labour & Employment, New Delhi. Passed candidate will get National Trade Certificate but will have no guarantee of employment after training.

17. The decision of Railway Administration regarding selection of candidates and their training will be final. If at any stage it is found that selected candidate has given wrong/false information and his/her integrity is found doubtful, then his/her candidature will be terminated at any stage without giving any notice.

18. If the candidate is found indulged in indisciplinary activities during the training period, his training will be terminated giving a week's notice.

Candidate will be solely responsible for the information furnished by him through online application. If it is found at any stage that the information furnished by him is incorrect, then his/her candidature will be cancelled. The Wagon Repair Workshop, Jhansi will not be responsible for any error, if committed, by the candidate during the course of submission of online application.

Note-

(i) Candidate must keep the printout of online filled application to produce it as a proof when called for document verification by this office.

(ii) The candidate along with the printout of online filled application must produce fee receipt, all technical and educational certificates, caste certificate, photo and Identification Card Andhanr Card and PAN Card in original as well as copy of all the documents attested by a Gazetted Officer.

(iii) Candidate will be debarred for verification process if he fails to produce printout of online filled application and requisite original documents.
