- A) Since the posts are over and above the sanctioned cadre due to the exigencies on temporary measure, no prescribed community distribution (SC/ST/OBC/EWS) is applicable. However,age relaxation will be given to candidates belonging to SC/ST/OBC/PwBDetc category as per extant rules. Age will be reckoned as on the date of notification.
- B) The vacancy is provisional and may increase or decrease as per administrative necessity. There may be 'wait-listed/stand-by' candidates against the notified panel/ select list who may be engaged as per necessity.
- C) Since the requirement is of urgent nature preference will be given to candidates residing in Pune and Pune District who can join immediately during lockdown.

- 2) Posts indicated herein may be kept unfilled at the discretion of administration
- 3) Contract can be terminated by the Railway at any time during the contract period by giving 15 days' notice without assigning any reason as per the terms and conditions laid down vide Railway Boards letter No. 96/E(GR) II/9/16 dated 23/02/2000 & No. 2008/E(GR) II/1/1 dated 16/07/2012, 28/03/2020 and 31/03/2020.

- 4) CMP Doctors/GDMOStaff nurse, Health & Malaria Inspector, Hospital Attds or OT Assistants, House Keeping Assistants who enter into contract with the railways will not have any claim or right for his/her continuity in service or automatic extension of the term of contract. Services rendered as fulltime Doctors/GDMO, staff nurse, Health & Malaria Inspector, Hospital Attds or OT Assistants, House Keeping Assistantswill not have any bearing in respect of considering of their period in regular selection through, RRB, RRC nor will it confer upon them any right for regularisation or absorption.
- 5) Eligible SC/ST/OBC/EWS candidates may apply along with caste certificate/necessary certificate for age relaxation as per extent rules same will be allowed to them.
- 6) Shortlisted staff will have to pass the prescribed medical examination.
- 7) They will work in railway isolation coaches of Pune Division, on roaster basis of 3 shifts (8 to 14 hrs, 14 to 20 hrs and 20 to 8 hrs of next day) with one weekly off. During the period of working of three months or less,they will be provided with appropriate PPE,accommodation & food facilities free of cost. They cannot go to their residence as per the guidelines of MOHFW for treatment of COVID cases
- 8) They can also be utilised at other Railway medical facilities like hospital, isolation ward, fever clinics quarantine facilities etc on Pune Division.

3) For Health & Malaria Inspector

B.Sc with chemistry (as main subject) and 1 year Diploma course of Health/ Sanitary Inspector from a recognized institute.

4) For Hospital Attendents/OT Assistants/ Housekeeping Assistants

SSC or ITI or equivalent.candidates having working experience in hospitals will be given preference

- 6) Original Walk-in interview is replaced by WhatsApp recorded conference call from a designated number 30/6/2020 as per the requirement of staff taking into consideration the gravity of this pandemic.
- 7) Document verification of only selected candidates will be done at the time of joining and in case of doubt the next candidate in the waiting list will be called for joining.
- 8) Candidates called for document verification should bring one set of Xerox copy of all documents along with originals required for the post, two passport size photographs, one cancelled cheque of own bank account, Aadhar Card, Pan card.

TERMS AND CONDITIONS FOR ENTERING INTO CONTRACT WITH TEMP CONTRACTUAL STAFF ON FULL TIME BASIS

1. The contract is valid only for threemonths from the date of joining, Period of contract is not extendable on any Grounds.

- 2. The full time CONTRACT staff who enter into contract with the railways will not have any claim or right for his/her continuity in service or automatic extension of the term of the contract.
- 3. During the validity of the contract, the staff will be at liberty to terminate the contract by giving 15 days notice to the railways. The contract can also be terminated by the railways at any time during the contract, by giving 15 days notice without assigning any reason whatsoever.
- 4. Any contract staff leaving his place of work on leave of absence should get prior permission of the Controlling Authority.
- 5. One Day off will be given in a week.
- 6. The monthly fee for Staff and the daily rate of proportionate reduction from the fee in the event of the staff absents himself/herself for periods exceeding those stipulated in the contract WILL BE ON PRORATA BASIS:
- 7. The staff shall be governed in respect of matter not referred to in these terms and conditions by any order/amendment on the terms contract issued by the Railways from time to time.
- 8. The contract staff shall attend to all the normal tasks which any regular medical staff is doing conventionally.
